

Iowa Credit Union League Vendor Membership Terms and Conditions

Effective Date: January 1, 2026

1. Introduction

These Vendor Membership Terms and Conditions ("Terms") govern the relationship between the Iowa Credit Union League (the "League", "we", "us", or "our") and the vendor ("Vendor" or "you"). By applying for or maintaining a Vendor Membership, you agree to abide by these Terms and all applicable policies referenced herein.

2. Eligibility

Vendor Membership is open to businesses, suppliers, and service providers who operate in industries related to or serving the interests of the League. The League reserves the right to approve, deny, or revoke membership at its sole discretion.

3. Membership Benefits

Vendors may be entitled to the following benefits (subject to change):

- Listing in the League's Vendor Directory on the League's website (www.iowacreditunions.com)
- Opportunity to sponsor League events at the League's discretion
- Priority access to certain levels of sponsorship at League's discretion of the League's annual convention and advertising
- Networking opportunities with industry members

The specific benefits of Vendor Membership may vary and are subject to modification without prior notice.

4. Membership Term & Renewal

- Vendor Membership is valid for a term ending on December 31st of each year unless otherwise stated.
- Membership must be renewed annually by submitting a renewal form and payment before the expiration date.
- Lapsed memberships may be reinstated at the discretion of the League, subject to payment of any outstanding fees.

5. Fees and Payment

- Membership fees are determined annually and published on the League's website or membership materials.
- All fees are non-refundable unless otherwise stated in writing by the League.
- Failure to pay dues on time may result in suspension or termination of membership.

6. Code of Conduct

Vendors are expected to uphold the highest standards of ethical and professional behavior, including but not limited to:

- Conducting business in a lawful and honest manner
- Avoiding misleading marketing or false representation
- Treating all League members, staff, and event participants with respect
- Complying with all League policies, rules, and applicable laws

Violation of the Code of Conduct may result in disciplinary action, including suspension or termination of membership.

7. Use of League Name and Logo

Vendor may not use the League's name, logo, or branding in any promotional materials without the League's prior written consent.

8. Events and Sponsorship

Participation in League events, advertising, or sponsorships may be subject to additional terms and approval. The League reserves the right to reject any promotional content that conflicts with its mission or values.

9. Privacy and Data Use

By joining, you consent to the collection and use of your business contact information by the League for purposes related to membership management, communications, and promotional activities.

10. Termination

The League may terminate your membership immediately if:

- You breach these Terms
- You engage in conduct detrimental to the League's reputation or mission
- You fail to pay required fees after notice

You may terminate your membership at any time by notifying the League in writing; however, no refunds will be issued for the remaining membership period.

11. Release of Liability. Vendor agrees to release the League, its affiliates, its members, its employees and its agents of any and all liability related to or arising out of Vendor's membership or related sponsorship of League events and to indemnify, defend and hold harmless the League, its affiliates, its members, its employees and its agents from a and against all claims, damages, liabilities, actions, costs (including attorney's fees) in connection with the Vendor's membership, and related sponsorship of League events or solicitation arising out of such sponsorships.

12. Amendments

These Terms may be amended from time to time by the League. Updated terms will be posted on the League's website, and continued membership constitutes acceptance of the revised Terms.

13. Governing Law

These Terms shall be governed by the laws of the State of Iowa, without regard to its conflict of law provisions.
